TERMS AND CONDITIONS

1. This "Proposal and Deal Rewards Promotion" (the "Promotion") offers a Gift (as described in Rule 6) to agents (as defined in section 4 of the Real Estate Agents Act 2008) ("Agents") who have met the criteria specified in rule 9 below and who have not been excluded by virtue of rule 6 or rule 12 below (a "Qualifying Agent") and who have entered the Promotion in accordance with the requirements of rule 9 below.
2. Entry into the Promotion is deemed to be acceptance of these terms and conditions (the "Rules").
3. For the purposes of these Rules, "Goodman" means together or separately as the case may require, Goodman Property Trust, Goodman Nominee (NZ) Limited, Highbrook Limited, Goodman NZ Highbrook Limited Partnership.
4. By participating, Agents grant Goodman exclusive permission to use their names, characters, photographs, voices and likeness in connection with the Promotion and for any future Promotion and marketing purposes and waive any claims to royalty, right or remuneration for such use.
5. All Agent's personal details must be valid and up to date and will be held by Goodman and may be used for the purpose of the Promotion and for future promotion and marketing purposes in accordance with Goodman's privacy policy (as amended from time to time) or such policy not exist, in accordance with the requirements of the Privacy Act 1993, unless otherwise directed by the Agent at the time of entry.
6. At Goodman's sole and absolute discretion, Qualifying Agents will be gifted a NZD\$500 Prezzy Card for each viewing and proposal (or such other similar card or offering determined in the sole discretion of Goodman). A 25% additional fee in the form of NZ Prezzy Cards will be gifted if the Agent completes the deal. This additional fee is capped at \$100,000 per deal and includes GST (if any). (Each a "Gift").
