TERMS AND CONDITIONS

1. This "\$500 Prezzy® Card Proposal Promotion" (the Promotion) is offered by Goodman and provides a Gift (the Gift) to eligible real estate agents (as defined in section 4 of the Real Estate Agents Act 2008) (each an Agent) who participate in and qualify for the Promotion in accordance with these terms and conditions (each a Qualifying Agent).
2. Participation in the Promotion constitutes acceptance of these Rules (the "Rules").
3. For the purposes of these Rules, "Goodman" means, jointly or severally as the context requires: Goodman Property Services (NZ) Limited, Goodman Nominee (NZ) Limited, Highbrook Limited, Goodman NZ Highbrook Limited Partnership.
4. By participating, Agents grant Goodman exclusive permission to use their names, characters, photographs, voices and likeness in connection with the Promotion and for any future Promotion and marketing purposes and waive any claims to royalty, right or remuneration for such use.
5. All personal information provided by an Agent must be accurate and up to date. Such information will be held by Goodman and may be used for the purposes of administering the Promotion and for future marketing activities in accordance with Goodman's privacy policy (as amended from time to time) and the Privacy Act 2020, unless the Agent advises otherwise in writing.
6. At Goodman's sole and absolute discretion, each Qualifying Agent will receive a NZD \$500 Prezzy® Card (or such other similar card or offering as determined by Goodman in its sole discretion) for each Qualifying Proposal and viewing. The value of the Gift is inclusive of GST (if any). All information provided by Goodman in relation to the Promotion forms part of these terms and conditions ("Rules"). By accepting the Gift, each Agent acknowledges and agrees to these Rules and confirms that they are responsible for advising their employer and/or any relevant regulatory or professional bodies, as required. Each Agent must ensure compliance with all applicable laws and regulations. The Agent and Goodman acknowledge that the Gift is income in the hands of the Agent and the Agent shall be solely responsible for the payment of any tax thereon.
7. To qualify for the Promotion, an Agent must, during the period ending 30 June 2026 ("Promotional Period"):
 - a) introduce a prospective customer to Goodman;
 - b) present a proposal in respect of a property owned by Goodman;
 - c) arrange and attend a meeting between the prospective customer and a Goodman representative; and
 - d) facilitate a viewing of the relevant Goodman property with the prospective customer (each a "Qualifying Proposal").All introductions, proposals, meetings, viewings, and resulting transactions must be acceptable to Goodman in its sole and absolute discretion.
8. A Qualifying Proposal does not include:
 - a) any introduction where Goodman has already commenced discussions with the prospective customer; or
 - b) any introduction of a person or entity that is already a customer or tenant of Goodman.
9. For each Qualifying Proposal, the Qualifying Agent must request a Goodman representative to complete a leasing deal nomination form ("Nomination Form") on the Agent's behalf. The Nomination Form must include details of the introduction, the relevant space, and the name(s) of the Agent(s) claiming the Gift. The completed Nomination Form must be submitted to Goodman either:

10. Qualifying Agents may only enter once in relation to each Qualifying Proposal. One Gift will be given per Qualifying Proposal. Agents may enter as many times as they like, provided each entry relates to a separate Qualifying Proposal.
11. The Promotion closes at 5pm 30 June 2026 (the "Promotion Period"). Proposals completed outside the Promotion Period will not qualify.
